Age: Preferable less than 35 years

Essential: Full time M. Com. / MBA (with major in Finance) having minimum 55% marks or CA/CMA or equivalent and 3 years of finance and accounts experience or B. Com. with 55 % marks and 5 years of finance and accounts experience.

Desirable: Working experience in educational Institute/academic Incubator/ R&D Organization of repute.
